

Your EURES Job 2 Germany 2021-2023

YEJ 2 Germany is a targeted mobility scheme for European citizens aged 18 and over interested in living and working in another EU member state, Iceland or Norway. Applicants receive custom advice from trained advisers and can apply for funding allowances to assist them in finding employment, an apprenticeship or a work placement in the destination country of their choice.

Funding description:

Applicants can receive a fixed allowance for relocation costs if they have found employment in another EU country, Norway or Island.

Funding requirements:

If you want to participate in the programme, you have to meet the following requirements:

- You are at least 18 years of age, **and**
- You are a citizen of one of the 27 EU member states, Norway or Iceland, **or**
- You have a lawful residence in one of the 27 EU member states, Norway or Iceland.
- You are being assisted by an adviser of the Federal Employment Agency or by a EURES-Adviser in one of the 27 EU countries, Norway or Iceland, **and**
- You have been counselled in this context prior to applying (*).
- You have received a confirmation of employment for a job or apprenticeship with a minimum duration of six months and statutory social security payments are included in the contract or a work experience placement with a minimum duration of 3 months.

Please check carefully as to whether or not you are eligible to make a funding application.

Is there a deadline to hand in the application?

Applications must be submitted before the planned journey. Applications received after the journey will not be considered.

Applicants who already live in Germany are not eligible to submit an application.

All applications must be submitted **either** to your adviser from the International Placement Services (IPS), the Migration Support Center (vWC), the Outgoing Team or the Specialized Services of the Federal Employment Agency, **or** to your EURES-Adviser.

Which supporting documents do I need to provide?

At the time of application:

- A copy of your valid ID, or, for non-EU citizens, a copy of your permanent residence title
- The employment confirmation form or a copy of your work contract

Within 10 days after starting work:

- The Confirmation of Employment Commencement form

When will the allowance be paid?

Payments will be made where possible before relocation, earliest 4 weeks before the commencement of employment/ entry date.

Missing or incomplete documents will lead to a delay in processing your application.

Please take into consideration:

If the employer contributes to the relocation costs, an application for a funding allowance cannot be submitted.

To enter and reside in an EU country, you need a valid passport or ID card and, for non-EU citizens, a valid residence title.

Please inform yourself in advance about any obligation to register according to residential law in the country of destination. In Germany, there is a legal requirement to register your address with the local authorities. Upon registration, you will receive a certificate of registration.

Applicants are responsible for arranging their own health and travel insurance.

Special Information

Relocation costs will only be covered as long as funds from another EU Commission mobility scheme for this measure have not been received.

The project ends on 28 February 2023. All supporting documents must be submitted by 31 January 2023.

There is no legal entitlement to payment of financial support until the application has been approved by the TMS team. The approval will be notified to the applicant, who is entitled to the grant, if applicable. The approval of applications is subject to the availability of funds.
