

## Can I receive financial support?

Yes, you may be eligible for financial support in addition to the information and recruitment service.

**Jobseekers** may be able to receive support to cover costs such as:

- travel for job interviews,
- relocation to the destination country,
- language training,
- recognition of qualifications.

**Employers (SMEs)** may be able to apply for financial support to cover some training and integration costs.

A *Reactivate* employment service can provide you with comprehensive information on the available financial support.



## Find out more

In order to find a job or register your vacancies, you should contact a *Reactivate* employment service. Direct services may not be available in all participating countries but the *Reactivate* employment services can help jobseekers and employers from any EU Member State.

# What is *Reactivate*?

*Reactivate* is an EU job mobility scheme for jobseekers over the age of 35.



The scheme's services benefit jobseekers and employers alike:

- As a **jobseeker**, *Reactivate* can help you find a job, traineeship or apprenticeship with an employer in a different EU Member State.
- As an **employer**, *Reactivate* can help you recruit for your vacancies by matching you with motivated jobseekers across Europe.

Services are free of charge and tailor-made to your needs. Placements have a minimum duration of 6 months (a shorter period for traineeships may apply).

## JOBSEEKERS

Are you...

- ▶ aged 35+? ✓
- ▶ a national and legal resident of an EU Member State? ✓
- ▶ having difficulty finding a job or training opportunity in your country? ✓
- ▶ willing to relocate and work in another EU Member State? ✓

If so, then *Reactivate* could be the scheme for you. *Reactivate* is open to candidates with different levels of education and/or work experience. Jobseekers who are unemployed will be targeted. If you are a successful candidate you may receive an integration programme and on-the-job training to help you settle into your job and new country.

### Tip!

If you're staying abroad temporarily and eligible for the European Health Insurance Card (EHIC) you can use it to access free or reduced cost medical care, should you fall ill. You will also need to arrange your own travel insurance.

## EMPLOYERS

Are you...

- ▶ a business or organisation registered in an EU Member State? ✓
- ▶ looking to recruit employees with a certain profile and struggling to find them in your own country? ✓
- ▶ willing to hire workers, trainees or apprentices aged 35+ from other EU Member States? ✓
- ▶ able to provide on-the-job training and other integration support for the recruited candidates? ✓

If so, then *Reactivate* could be the scheme for you. It's a free service to help you recruit for positions from a pool of candidates located across the EU.

What's more, small and medium-sized enterprises (SMEs) may be given enhanced services, including financial support (see overleaf).

## What's special about *Reactivate*?

By connecting jobseekers with employers (and employers with jobseekers) across the EU, *Reactivate* may help you find the work opportunity you have been looking for, as well as strengthening the competitiveness of EU businesses.
